Turk upsets UCLA with Overtime Basket

Veteran Saint Mary's basketball observers were deeply distressed recently when the spunky Gaels, red pajamas and all, were dumped by the highly-touted Cal State Long Beach 49ers, 110-76.


Here was the Gaels' chance for national recognition. The 49ers were actually mentioned in Sports Illustrated's College Basketball Issue, and Gael fans saw a win as an opportunity to compare scores and determine how the team would do when it met UCLA in the NCAA Play-offs.

Certainly a win over CSCLB would indicate that the Gaels would go all the way in the




STUPID BONACCI

We the members of Students and Teachers United for Progressive and Innovative Demands are sick and tired of the prostitution of Saint Mary's College. We see the college being sold to the money moguls of big industry and in return they receive the valuable diplomas from this prestigious institution! We see hoards of money being senselessly squandered on and in the athletic department while the washing machines on campus remain unrepaired. The most disgusting prostitution is that of our very own student government. STUPID has sat by and watched our student body fees going into the pockets of those students who are interested in student government and this disgusts us. It has been continually true that only those students interested in student government have received money from Student Body fees while the majority of the students continually receive nothing. Such inane groups as the Executive-Council, the Collegian, The Black Student Union, the Debate Club and minor sports, all of which represent the same interests on campus, receive tens of thousands of dollars while very little is ever spent on the average non-involved student.

Pat Bonacci our social chairman has done his best to repair this situation but he has had been met with difficulties at every turn. He is allowed to spend only \$9,000 on the entire student body while the student body funds are in excess of \$50,000. Given enough money Pat could effectively cure most of the major problems of this college. He would be able to see that the washing machines are fixed, the roads paved, that the only dogs on campus belong to former college presidents, that our cheerleaders are properly outfitted and that the SMC on the hill is continually lighted. Pat, being a traditionalist, sought to receive the allocation for his social committee by the standard channels, he did not realize that in a move to cut red tape the Student body treasurer had developed a new method, used first by the cheerleaders, just ask him for money and he writes a check, with the proper O.K. It is not the fault of the persons involved however, it is the fault of the system.

But enough of this tearing down of the present system, we must look at what is right with it... ergo we demand that it be thrown out.

Our committee has researched this problem for three years now and believe that we have come up with a progressive and innovative substitute. There will be a legislative branch of the government with one representative from each floor. Not from just the dorms but for every floor in the school. The students would be represented by 16 students (one from each dorm floor), the faculty would be represented by 8 professors (3 from the science complex, 3 from Dante, 1 from the gym and 1 from the psychology building), the day students would have 4 representatives (3 for the library and one for the brickpile) and the administration would have 4 votes in the legislative branch (1 for the rent-a-cop box at the main gate, 1 for the south end of DeLaSalle, 1 for the east end of Dante and one for the administration building). All members to the legislative branch would be picked by lot from their respective groups and any 7 members would constitute an official meeting.

The legislative branch will allocate all the money taken in by the school and the student body, appoint new faculty and administrators, build new buildings and parking lots, appoint the trustees and the regents of the college, issue checks in payment of debts (all 32 members must sign each check) and finally they must give Pat Bonacci at least 50% of all of their money.

The duties of the executive branch would be to assist the newly hired rent-a-cop in apprehending speeders and illegal parkers and in emptying the trash cans in the students' rooms.

DRAFT DODGE COLUMN:

HOMOSEXUALITY AND THE DRAFT

Some young men have been studying the Army's list of disqualifying medical and psychological defects in search of ailments whose only objective signs are symptoms which the examinee alone can relate. Bearing letters from their family physician or psychiatrist, these young men reveal back injuries, migraine headaches, allergies, or psychoses, etc., developed shortly before their preinduction physicals. With only the family doctor's letter and the registrant's own testimony to go on, the examining doctor will usually reject.

One common ailment is listed by the Army as "character and behavior disorders as evidenced by... overt homosexuality or other forms of sexual deviant practices such as exhibitionism, transvestism, voyeurism, etc." Notice, the rejection is for OVERT homosexuality, i.e., a PRACTICING homosexual not a state of mind.

In some cities, groups have organized and trained to become "overt homosexuals" in order to convince skeptical private doctors or Armed Forces Entrance and Examining Station (AFEES) personnel. Other registrants have located helpful doctors through organizations such as the Medical Committee for Human Rights.

Will these young men be rejected? Under the law, AFEES examining doctors have no obligation to disqualify a registrant merely because he appears at this physical with a doctor's letter stating he is an overt homosexual. (Bear in mind that under Army Regulations, an examining doctor can choose to ignore letters from a psychologist, as distinguished from a full-fledged psychiatrist). The doctor may exercise his own judgement and decide the examinee is acceptable. He may follow the Army Regulations' advice that "the more desirable time for evaluating the individual's functional ability from a psychiatric standpoint is during his basic training period (i.e., in boot camp.)

On the other hand, the examining doctor may follow an informal directive recently issued to examining doctors: "More credence should be given to diagnosis made under private physicians, especially in the area of psychiatry. If evidence is submitted which is disqualifying, then disqualify."

Is there any way for the examining doctor to know for certain if the examinee is faking? Our interviews revealed a divided opinion. Dr. Gabriel Kirschenbaum, the chief Medical Advisor for the New York City Selective Service System, noted that homosexuals who claim, for instance, to have engaged in anal intercourse should have developed physical traits which can be diagnosed by the experienced physician. These traits may include an enlarged rectum, anal fissures and fistulae, or "plague" (venereal warts in the anal canal).

An AFEES doctor contended that he could spot a "faker" a mile away. He used "shock" techniques. For example, he would begin his interview with the question: "When was the last time you got laid?" After an hour of this, he claimed, the "fakers" would break down.

Col. Paul Akst, the State Director for New York City Selective Service, reported that the AFEES maintain lists of "helpful" doctors. When a letter is received from these doctors, it is disregarded. He indicated that if the AFEES received more than six letters from one doctor, he qualifies for the list.

Finally, the Federal Bureau of Investigation sometimes helps out by sitting in on the training sessions for would-be homosexuals. It is worth bearing in mind that faking homosexuality to evade induction is a crime punishable by up to five years in prison and/or a \$10,000 fine.

In general, however, those doctors this reporter felt were being frank indicated that, in fact, there is no real way of knowing if an examinee is faking. As one AFEES doctor confessed: "If the kid knows what he's doing, and doesn't overdo it, he'll probably be rejected. Our attitude is, if in doubt, reject."

The variety of opinions expressed by the examining doctors probably foretells the varying results examinees will face. A suspicious doctor is likely to spot faking in an actual homosexual. Psychiatry is hardly an exact science. Thus, the very attractiveness of the undiagnosable ailment makes it difficult to question adverse findings.

Let us assume a young man who has brought in documentation is nonetheless found acceptable. Does he have any recourse in the courts? The answer is no. The courts believe the right to reject belongs to the Armed Forces, for whose benefit the right exists. Abuse of this right is, therefore, deemed to hurt the Armed Forces, not the registrant. Courts simply will not review the judgement of the Army's examining doctors.

Though receiving a medical deferment on psychiatric grounds may not be very difficult, the deferment may come back to haunt the registrant later in his life. In the near future, this column will discuss this problem and how to deal with it.
